**ORDER TO EXPUNGE CRIMINAL HISTORY RECORD UNDER SECTION 943.0585,  
FLORIDA STATUTES, AND FLORIDA RULES OF CRIMINAL PROCEDURE 3.692**

**THIS CAUSE** having come to be heard before me on this date upon a petition to expunge certain records of the Petitioner's arrest on [REDACTED], by the Sanford Police Department, for: (i) Sexual Battery by Custodian (Victim over 12 y/o but under 18 y/o), Florida Statute § 794.011(8)(b), the court having heard argument of counsel, reviewed the available record and/or being otherwise fully advised in the premises, the court hereby finds:

1. The Petitioner has never been previously adjudicated guilty of a criminal offense or a comparable ordinance violation nor adjudicated delinquent for committing a felony or a misdemeanor specified in §§ 943.051(3)(b), 943.0584, Florida Statutes.

2. The Petitioner was not adjudicated guilty of, nor adjudicated delinquent for committing any of the acts stemming from the arrest or criminal activity to which the instant petition pertains.

3. The Petitioner has not secured prior records expunction or sealing under §§ 943.0585 or 943.059, Florida Statutes, or under former §§ 893.14, 901.33 or 943.058, Florida Statutes, or the record is otherwise eligible for expunction because it has been sealed for at least 10 years.

4. This record has either been sealed for at least 10 years; or no indictment, information or other charging document was ever filed in this case against the petition; or an indictment, information or other charging document filed against the defendant was dismissed by the prosecutor or the court; or the petitioner is seeking to expunge a criminal history record associated with a not guilty verdict.

5. A Certificate of Eligibility [REDACTED] has been issued by the Florida Department of Law Enforcement and accompanied the petition for expunction of nonjudicial criminal history records.

WHEREUPON IT IS:

**ORDERED AND ADJUDGED** that the petition to expunge is hereby **granted**. All judicial and non-judicial criminal history records pertaining to the above-styled case shall be expunged in accordance with the procedures set forth in Florida Rule of Criminal Procedure 3.692; and it is further

**ORDERED AND ADJUDGED** that the clerk of this court shall forward a certified copy of this Order to the State Attorney's Office for Seminole County, the Sanford Police Department and the Seminole County Sheriff's Office, who will comply with the procedures set forth in § 943.0585, Florida Statutes, and appropriate regulations of the Florida Department of Law Enforcement, and who will further forward a copy of this order to any agency, state and federal, listed or unlisted hereunder, that their records reflect has received the instant criminal history record information; and it is further

**ORDERED AND ADJUDGED** that the Sanford Police Department and any agency whose records reflect it has received the instant criminal history record information shall expunge and completely remove all trace/information concerning indicia of arrest or criminal history record

information regarding the arrest or alleged criminal activity to which this petition pertains in accordance with the procedures set forth in § 943.0585, Florida Statutes, and Florida Rule of Criminal Procedure 3.692.

All costs of certified copies involved herein are to be borne by the Petitioner.
