**ORDER TO SEAL CRIMINAL HISTORY RECORDS UNDER SECTION 943.059,  
FLORIDA STATUTES, AND FLORIDA RULE OF CRIMINAL PROCEDURE 3.692**

**THIS CAUSE** having come to be heard before me this date upon a petition to seal certain records of the Petitioner's arrest on [REDACTED] and on [REDACTED] by the Okaloosa County Sheriff's Office, for: (I) Issuing Check with Insufficient Funds, Florida Statute § 832.05(4)(a); (II) Issuing a Worthless Check, Florida Statute § 832.05(2)(b); and (III) Failure to Appear, Florida Statute § 843.15(1)(b), and the court having heard argument of counsel, reviewed the available record and/or being otherwise fully advised in the premises, the court hereby finds:

1. The Petitioner has never been previously adjudicated guilty of a criminal offense or a comparable ordinance violation, nor adjudicated delinquent for committing a felony or a misdemeanor specified in §§ 943.051(3)(b) or 943.0584, Florida Statutes.
2. The Petitioner was not adjudicated guilty of nor adjudicated delinquent for committing any of the acts stemming from the arrest or criminal activity to which the instant petition pertains.
3. The Petitioner has not secured prior records expunction or sealing.
4. A Certificate of Eligibility has been issued by the Department of Law Enforcement and accompanied the petition for sealing of nonjudicial criminal history records.

WHEREUPON IT IS:

**ORDERED AND ADJUDGED** that the petition to seal is hereby **granted**. All judicial criminal history records pertaining to the below-styled cases shall be sealed in accordance with the procedures set forth in Florida Rule of Criminal Procedure 3.692;

**ORDERED AND ADJUDGED** that the Okaloosa County Sheriff's Office and any agency, state and federal, that their records reflect has received the instant criminal history record information shall seal and completely remove all information concerning indicia of arrest or criminal history record information regarding the arrest or alleged criminal activity to which this petition pertains in accordance with the procedures set forth in § 943.059, Florida Statutes, and Florida Rule of Criminal Procedure 3.692.

All costs of certified copies involved herein are to be borne by the Petitioner.
