**ORDER TO SEAL CRIMINAL HISTORY RECORDS UNDER SECTION 943.059,
FLORIDA STATUTES, AND FLORIDA RULE OF CRIMINAL PROCEDURE 3.692**

THIS CAUSE came before the Court for consideration on a petition to seal certain records of the Petitioner's arrest under case number [REDACTED] which took place on [REDACTED] by the Marion County Sheriff's Office, for: (i) Obtaining Merchandise or Money with False Receipt, Florida Statute § 812.017(2), and (ii) Petit Theft (\$100 or more but less than \$750), Florida Statute § 812.014(2)(e), and re-arrest under case number [REDACTED] taking place on [REDACTED] by the Marion County Sheriff's Office, for: (iii) Grand Theft (\$750 to Less than \$20,000), Florida Statute § 812.014(2)(c). The Court reviewed the available record and is otherwise fully advised in the premises, and finds:

1. Petitioner has never been previously adjudicated guilty of a criminal offense or a comparable ordinance violation, nor adjudicated delinquent for committing a felony or a misdemeanor specified in §§ 943.051(3)(b) or 943.0584, Florida Statutes.

2. [REDACTED] was not adjudicated guilty of, nor adjudicated delinquent for committing any of the acts stemming from the arrest or criminal activity to which the instant petition pertains.

3. Petitioner has not secured prior records expunction or sealing.

4. Petitioner's arrest under case number [REDACTED] which took place on [REDACTED] is directly related to the second arrest under case number [REDACTED] which took place on [REDACTED]

5. A Certificate of Eligibility [REDACTED] has been issued by the Department of Law Enforcement and accompanied the petition for sealing of nonjudicial criminal history records.

Therefore, it is

ORDERED AND ADJUDGED as follows:

1. The petition to seal is **granted**. All judicial and non-judicial criminal history records pertaining to the above-styled cases, including directly related case number [REDACTED] shall be sealed in accordance with the procedures set forth in Florida Rule of Criminal Procedure 3.692.

2. The clerk of the court shall forward a certified copy of this Order to the State Attorney's Office for Marion County and the Marion County Sheriff's Office, who will comply with the procedures set forth in § 943.059, Florida Statutes, and appropriate regulations of the Florida Department of Law Enforcement, and who will further forward a copy of this order to any agency, state and federal, as well as those listed hereinbelow, that their records reflect has received the instant criminal history record information.


3. The Marion County Sheriff's Office and any agency whose records reflect it has received the instant criminal history record information shall seal and completely remove all information concerning indicia of arrest or criminal history record information regarding the arrest or alleged criminal activity to which this petition pertains in accordance with the procedures set forth in § 943.059, Florida Statutes, and Florida Rule of Criminal Procedure 3.692.

4. All costs of certified copies involved herein are to be borne by the Petitioner.
